

## EXHIBIT A TO LICENSE AGREEMENT

### MARCO ISLAND CIVIC ASSOCIATION RESIDENTS' BEACH RULES AND REGULATIONS

1. NO GAS OR PROPANE GRILLS. You may bring charcoal and use the grills supplied by MICA.
2. The large chickee may be used by groups of 30 or more persons.
3. Children must be accompanied by adult while in playground area.
4. An adult must supervise children at all times.
5. Absolutely no persons allowed in Millennium Fountain or the drinking fountain.
6. No vehicles permitted over sidewalk and on grass area. Vehicles must remain on blacktop/parking lot.
7. No inflatable play structures, trampolines, or any similar items.
8. No water balloons, water guns or water paraphernalia permitted.
9. Place all debris in trash receptacles. (Extra bags at gatehouse.) See #24 for Sarazen Park use!
10. No glass permitted on beach area.
11. No fireworks permitted.
12. No open fires permitted.
13. Any furniture relocated during party must be replaced to original location.
14. No tents permitted.
15. PARKING IS FOR MEMBERS ONLY. MEMBERS MAY NOT SHUTTLE GUESTS. MEMBERS MAY ENTER ONCE WITH UP TO FIVE PERSONS ONLY.
16. \$5.00 per person charge for Non-Residents' Beach Members who enter without a Residents' Beach Member. Must be paid by member prior to event at MICA office. This allows non-member to walk onto property.
17. GUESTS OF LICENSEE MUST LEAVE WHEN EVENT IS TERMINATED AS INDICATED IN PARAGRAPH 1 OF LICENSE AGREEMENT.
18. Completion of application form for use of premises does not reserve chickee huts or tables.
19. Licensee will be billed and shall be responsible for any additional clean-up or repair costs that may be incurred as a result of this Event.
20. Every effort will be made to allow parking for handicapped non-members with handicapped parking permits.
21. ~~\_\_\_\_\_~~ 50 persons or more may only use the picnic facilities at Sarazen Park.
22. From December 1 through April 30, no groups will be permitted to use the facilities at Residents' Beach at any time Friday through Sunday or on holidays, with the exception of children's birthday parties with less than 25 people in attendance.
23. No fundraising activities are permitted.
24. \$1,000 deposit is required for wedding ceremonies at Residents' Beach, which will be refunded subject to approval of MICA/Residents' Beach Management. All chairs, arches, etc., must be immediately removed following ceremony.
25. SARAZEN PARK USERS MUST TAKE TRASH WITH THEM - REMOVE FROM SARAZEN PARK PROPERTY.
26. A \$250 DEPOSIT IS REQUIRED FOR USE OF SARAZEN PARK. DEPOSIT SHALL BE REFUNDED SUBJECT TO APPROVAL OF MICA/RESIDENTS' BEACH MANAGEMENT.
27. MICA/Residents' Beach Management reserves the right to transfer any event to Sarazen Park.
