

have a MICA beach pass:

- 1) Marco Island residents can purchase a beach pass at the MICA office.
- Get a Collier County beach sticker and park in the Collier County parking lot, which is adjacent and east of the MICA lot. You cannot park in the MICA lot with this sticker.
- 3) Pay the fee for parking in the Collier County parking lot (\$8).
- 4) Ride with someone who has a beach pass.
- 5) Give a ride to someone who has a beach pass.
- 6) Be aware that Park Rangers sometimes hassle you, claiming the parking is for the beach only, and will ticket you if you go to the picnic. HINT: Don't make it obvious you're going to picnic (e.g. passing chairs over fence).
