

November Buddy Trip November 18, 2019 by Joe Perino



On this day the bite was on the light side and only about fifty fish were caught by the group. As the morning wore on, winds picked up substantially which made fishing even more challenging. Nevertheless, some quality fish were caught with Mike Larsen landing the catch of the day; a very nice Largemouth Bass estimated to weigh around eight pounds. Several 18-inch and 17-inch fish were also reported caught. Most of the fish were caught on plastic worms and a few hit plastic frogs. All the fish were released.

This venue has become a favorite event for the MSC kayakers. The site has easy access, excellent cover for fish and a healthy population of Largemouth Bass. There are a few alligators in this quarry lake, but these reptiles have shown no aggressive behavior.


