

Action is needed ASAP, in that our Nitrogen and Phosphorus levels are as bad as they have ever been based upon the latest monthly sampling data.

On the lighter side (literally), two of our long time, and highly skilled members were found to be a little slow on the "reel-in", ending up with a "lighter" catch.
