Two important notes for membership in the Marco Sportfishing Club -

- 1. Marco Island, Goodland, Port of the Isles, or Isles of Capri legal residency is required for membership in the Marco Sportfishing Club. (*legal residency means you will live in one of these towns fulltime, part time, or for a rental period in 2022 unless "grandfathered" by previously meeting this requirement while a member in good standing*).
- 2. You must agree to the waiver, release, and indemnification.

The American Patriot is a luxurious 135' x 29' state of the art vessel that ventures beyond the typical MSC offshore angler's fishing grounds. Three-





What's Happening Offshore...

Red Grouper reopens in Federal and State waters and Lane Snapper reopens in Federal Water Jan 1, 2022. Gray Triggerfish harvest remains closed in Federal and State waters until March 1, 2022.

Don't forget...for \$10 you can enter into a lottery for 1 of 200 permits to be issued in 2022 to harvest 1 Goliath Grouper between 20" to 36". If you are one of the "lucky" ones selected, and for an additional \$500, the permit is yours.

The Snapper are out there on the wrecks and ledges at all depths, Permit are migrating south and will be gone from our waters soon. Cobia are here near structure and around the bait pods.

Pick a calm day and get out there and have some fun...and be safe.

Offshore Events...

MSC Offshore Slam proudly sponsored by Rose Marina – We are down to the final month of fishing so get out there and complete your slams and upgrade fish before it's too late. Super Snapper Nearshore Fall 2021 – Given the closure of Red Grouper in Federal waters, the escalating cost of fuel, and recent dive reports of abundant snapper on nearshore reefs / ledges, we have decided to have a Super Snapper Nearshore event (75' maximum depth). The Captains Meeting will be at Crazy Flamingo Friday Dec 3 at 4:00 pm. The fishing window will be Saturday Dec 4 through Sunday Dec 12, 2021. This window includes the new moon and several high solunar activity days. Prizes will be awarded for the top three boats based on the combined length of 3 legal Mangrove or Yellowtail Snapper. In addition, a prize for the largest legal Mangrove or Yellowtail Snapper will be awarded, as well as each of the two wild card fish – Gag Grouper and Tripletail. The event flyer and sign-up sheet are attached. Looking forward to a great turnout and to get some of the smaller boats involved given the 75" max water depth and the fact that legal fish of all 4 species can be readily caught within this depth range.

- 5. ALL Captains must declare their fishing day in advance to Jim.
- 6. "Two Line Rule" applies No more than two rods per angler.
- 7. The fish being entered must be photographed individually on a vertical edge tournament ruler, mouth closed and tight against the vertical edge of the ruler (not following the measurement rules may result in a reduction in size if the measurement is not clearly evident). All photos must be emailed to Jim Scarpa at the email address above on the day caught.

Marco Island Water Quality Report Submitted by Phil Wanzenberg

In this, my initial report dedicated to Water Quality issues, I wish to provide readers with the following information:

- 1. Activities of the Water Advisory Committee (WAC)
- 2. The Harper Report and what the next steps may be.
- 3. What can Marco Island residents can do to help improve our waterways and Water Quality.

I have attended WAC meetings on an occasional basis for the last seven years. The one constant I have noticed is that all the committee members have been dedicated volunteers who apply their skills and knowledge for the benefit of Marco Island residents. Members have complimentary backgrounds which result in very credible recommendations concerning Water Quality issues, which are then presented to the City Council and Manager. These recommendations are sensitive to available resources and the ability to implement them resulting in meaningful effectiveness. Over the years they have pushed for increased testing in critical waterway areas which has resulted in increased City Council attention.

The Harper Report was 2 years in the making. It was designed, implemented, and formally presented by Environmental Research & Design Inc. It is a direct result of the August 22, 2019, State of Florida Impaired Water Citation (published in the October 2019 Newsletter) and the ever more troubling testing results. The report is very long and detailed, but each section has a recommendation and a short summary that explains the issues in a clear manner. The report is expected to be the primary resource used by the City Council in the development of a Master Plan regarding Water Quality improvements.

As residents of Marco Island, year-round or seasonal, we must realize that we are in a unique environmental bubble. As our surrounding waters decline, one of the main reasons we wish to live in Marco, is declining as well. This includes wildlife such as Manatee and Dolphins, fishing, boating in general and beach time and swimming in the Gulf. In addition to attending the WAC meetings, (3rd Thursday of the month at 9:00 am in the Community Mtg. Room), whenever possible, please see the list below for things that each of us can do to improve Water Quality around our homes and on our Island:


- 1. Limit fertilizer use and know the City Ordinances. Also talk to your neighbors regarding fertilizer use.
- Always avoid having grass, leaves or other yard debris going into your channels. Advise your landscaping service of this and watch their work and make sure they are licensed and know the City Ordinances.
- 3. Always have your boat waste pumped out, dumping is against the law. Advise others to do the same.
- 4. Use environmental friendly boat and dock cleaners and if you use a service make sure they are using the correct cleaners.
- 5. No gutter or pool discharges are permitted into the channels. Be sure your neighbors also know this type of discharge is illegal.

These items are just a few of the things each of us can do to help improve Water Quality in Marco's waterways.



POLICY Summary

- 1) Due to scheduling and caterer contracts, picnics will be held rain or shine (except in the event of named storms).
- 2) No refunds will be given for cancellations on the day of the picnic.
- A list of paid attendees will be published several days prior to the picnic so there will be no confusion about who has paid or not paid.
- In order to facilitate the above and allow proper notification to caterers, payment deadline is one week prior to the picnic.
- 5) Payment must be in the hands of the picnic chairman by the deadline, not in the mail (just like the banks, so be aware of holidays).
- 6) The late fee is \$3 per/person.
- 7) Walk-in fee is \$5 (plus \$3 late fee).
- 8) Guests cost more (other fees above also apply).

CURRENT PICNIC PARKING RULES Picnics are held at the MICA Sarazen Park (910 Swallow Ave.) and MICA membership is required. There are several alternatives if you do not qualify for MICA membership:

- Collier County residents can get a Collier County beach sticker and park in the Collier County parking lot, which is adjacent and east of the MICA lot. You cannot park in the MICA lot with this sticker. Be aware that Park Rangers sometimes hassle you, claiming the parking is for the beach only, and will ticket you if you go to the picnic. HINT: Don't make it obvious you're going to picnic (e.g. passing chairs over fence).
- 2) Pay the fee for parking in the Collier County parking lot (\$8).
- 3) Ride with a MICA member.
- 4) Have a MICA member ride with you.
- 5) Parking on the swales within a mile of South Beach Access or Sarazen Park is not permitted. The current fine is \$95.
