### WAIVER, RELEASE, AND INDEMNIFICATION

I acknowledge that sport fishing has inherent risks for anyone, including, but not limited to drowning, injuries from equipment, inclement and inhospitable weather conditions, fish and malfunctioning vessels, and unavailability of immediate or prompt medical attention.

In consideration of being permitted to participate in the activities of the Marco Sportfishing Club, Inc. (the "Club") a Floridanot-for profit Corporation, for any purpose including, but not limited to, observation, use of facilities (whetherowned, leased or simply utilized by the Club, hereinafter referred to as the "Premises")or equipment, or participation in any way, including participation in any off-site programs, the undersigned, for himself or herself, his or her minor children, his or her family members, agents, employers, successors, and/ or assignors, and any personal representatives, heirs and next of kin (hereinafter referred to as "Releasor"), hereby acknowledges, agrees, and represents that they:

- Release, waive, discharge and covenant not to sue the Club., its directors, officers, if acting in said capacity, and any employees and agents (hereinafter referred to as "Releasee") from all liability to the releasor for any loss of damage, and any claim or demand therefore on account of injury to the Releasor's person or property or resulting in death of the undersigned whether caused by the negligence of the Releasee or otherwise while the undersigned is in, upon or about the Releasee's Premises, or participation in any Club off-site programs or equipment.
- Indemnify and hold harmless the Releasee from any loss, liability, damage, or cost that they may incur due to the presence of the undersigned in, upon or about the Releasee's premises or in any way observing or using any facilities or equipment of Releasee, including participating in any Club off-site events, programs, or gatherings, said indemnification to include attorneys' fees (including those on and in any bankruptcy proceeding)
- 3. Hereby assumes full responsibility for and risk of bodily injury, death, or property damage due tonegligence of the Releasee or otherwise while in, about or upon the Releasee's Premises, or participation in any off-site programs, and/or while using the premises of any facilities hereon.

The Releasor further gives permission to the Club. to use, without limitation or obligation, photographs, film footage or tape recordings that may include Releasor's images or voices for purposes of promoting the Club.

The Releasor further expressly agrees that the foregoing waiver, release, and indemnification agreement is intended to be broad and inclusive as is permitted by the laws of the State of Florida and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
